TERMS AND CONDITIONS

- 1. Service Provider Obligation.** Interglobe Sire Service agrees to perform its semen collection process to the highest industry standards. All necessary procedures and precautions will be followed and executed to obtain high quality semen with adequate sperm cell concentration and strong motility post-freeze.
- 2. No Warranty.** Interglobe Sire Service does not offer any expressed or implied warranty on the collection, storage and/or sale of semen. Said collection is deemed "as is."
- 3. Term of the Agreement.** This Agreement begins at the time of Execution of said Agreement by Parties and terminates upon the release of any held semen specimen by Interglobe Sire Service.
- 4. Animal Welfare.** The animal will be handled carefully and treated by a local qualified veterinarian in the event of any sickness or injury during the collection of semen. Owner of said animal will be solely responsible for expenses associated with animal care.
- 5. Insurance.** Service Provider shall maintain adequate insurance at all times. Owners of animal are encouraged to maintain insurance coverage on said animal.
- 6. Liability.** Parties agree to and do release each other from any and all liability in the event of injury or death of the animal, damage to or defect in semen during its collection, storage, or transportation or equipment in the standard collection of semen from the animal designated above in this Agreement, or injury sustained by the Service Provider or its employees while handling or collecting the semen. The Owner is responsible for maintaining proper insurance on said animal.
- 7. Payment.** Payment is due upon receipt of invoice. Owner agrees to use the semen specimen collected to serve as collateral for payment for services performed by Interglobe Sire Service.
- 8. Default.** If Owner shall fail to pay for services within ninety (90) days of receipt of invoice, Interglobe reserves the right to merchandise or dispose of collateral to satisfy the obligation owed. Owner acknowledges Service Provider's right to dispose of collateral as deemed necessary and the Owner relinquishes all rights and privileges associated with the collateral.
- 9. Dispute Resolution.** Should a dispute arise between Owner and Service Provider regarding this Agreement; Illinois Courts shall have jurisdiction.
- 10. Compliance With Laws.** Throughout the Agreement, Parties shall comply with all applicable federal, state and local laws, ordinances, codes and regulations.
- 11. Miscellaneous.**
 - a. This Agreement shall be governed and construed in accordance with the laws of the State of Illinois.
 - b. Each provision of this Agreement shall extend to and shall bind and inure to the benefit of the parties hereto and their respective successors and assigns.
 - c. No modification, waiver or amendment of this Agreement or any of its conditions shall be binding upon Owner or Service Provider unless in writing signed by both parties.
 - d. The invalidity of any of the provisions of this Agreement will not impair or affect in any manner the validity, enforceability or effect of the rest of this Agreement.
 - e. This Agreement may be executed in counterparts, with all of the counterparts comprising one and the same Agreement, valid and binding on all of the parties.
